**IN ORDER TO LIMIT EXPOSURE WITH FERRY CREW ON BOARD THE M.V. SANDY GRAHAM PASSENGERS ARE REQUIRED TO REMAIN IN THEIR PERSONAL VEHICLES WHILE IN TRANSIT. MASKS ARE REQUIRED TO BE WORN SHOULD YOU NEED TO EXIT YOUR VEHICLE AND THE VEHICLE DECK. WE ALSO WILL BE LIMITING PASSENGER QUARTERS CAPACITY TO THE ABSOLUTE MINIMUM TO ALLOW FOR THE REQUIRED MINIMUM DISTANCING FROM OTHER PASSENGERS. TOTAL COMBINED PASSENGER CAPACITY INCLUDING THOSE ON THE VEHICLE DECK CANNOT EXCEED 98 PASSENGERS.**

**MAXIMUM 5 PERSONS PER CAR.**

**SANDY GRAHAM** - Department of Transport Regulations will not permit passenger capacity to exceed 98. Load Restriction: 156,000 lbs (98 passenger/6 crew/28 vehicles per loaded trip. Beausoleil First Nation does not assume responsibility for any loss, theft or damage to goods.

**INDIAN MAIDEN** -Department of Transport Regulations will not permit passenger capacity to exceed 70 including crew. However we will be lowering capacity to 28 PAX to allow for the required distancing from other passengers. Beausoleil First Nation does not assume the responsibility for any loss, theft or damage to goods.
