## NOTICE OF VOTE

**TO: MEMBERS OF BEAUSOLEIL FIRST NATION**

**TAKE NOTICE** that a Ratification Vote shall be held in accordance with the Beausoleil First Nation Community Ratification Process in order to determine if Eligible Voters approve the *Beausoleil First Nation Land Code* and the *Individual Agreement on First Nation Land Management*. The Land Code and Individual Agreement shall be approved if a majority of the participating Eligible Voters vote to approve them.

The following question will be asked of the Eligible Voters of Beausoleil First Nation by ballot:

**"Do you approve:**

- **The *Beausoleil First Nation Land Code*, dated January 15<sup>th</sup>, 2015 and**
- **The Individual Agreement with Her Majesty the Queen in Right of Canada, dated for reference April 15, 2019?**

An Advance Poll for the Ratification Vote will take place on Friday, the 21st day of June, 2019 from 9:00 a.m. until 1:00 p.m. at:
