COTTAGE SUBDIVISION BUILDING PERMIT PROCESS

1. PERMIT APPLICATION (PART 1) AND CONSTRUCTION DRAWINGS

A permit application (Part 1) is required to be completed by the owner, applicant or their designate (architect, engineer, or contractor) with a description of the proposed construction and submitted to the Beausoleil First Nation Lands & Resources Department. The applicant is also required to submit two full copies of construction drawings and specifications for review by the Lands & Resources Department. One copy of the plans will be returned to the applicants upon issuance of the Building Permit.

2. OTHER DOCUMENTATION

2.1. Owner's Letter of Undertaking

The owner/applicant is required to submit to the Lands & Resources Department a letter of undertaking which states that the subject construction will be designed and reviewed by an architect, professional engineer or both.

2.2. Owner's Letter of Approval (PART 2)

A non-resident applicant is required to submit to the Lands & Resources Department written authorization from the owner to make the building permit application.

2.3. Construction Drawings (PART 3)

A Site Plan Layout and two full sets of construction drawings for the proposed construction shall be submitted to the Lands & Resources Department and bear the seal of the design architect and other professional disciplines for review by the Lands & Resources Department prior to the issuance of the building permit.

4. The applicant will submit all documentation as outlined above to the Lands & Resources Department for review, upon review the department will either;

- a. Requests additional information from the applicant
- b. Approves the application
- c. Approves the application conditionally
- d. Denies Application

5. Upon approval applicant pays associated fees to Beausoleil First Nation

6. Upon receipt of fees and approval of application the Lands & Resources Department will provide the applicant with a Beausoleil First Nation Lands & Resources Department Cottage Lot Permit to be posted on the approved cottage lot.

BEAUSOLEIL FIRST NATION BUILDING PERMIT GUIDELINES

- The height of the building should not exceed 30 feet/ 9 metres from ground level.
- Any building/ improvements shall be 10 feet/ 3 metres from all property boundaries.
- The exterior of the building should be aesthetically acceptable.
- To obtain a Building Permit; Full Payment is required, as per schedule attached.
- The Lessee, Applicant and or Contractor are required to schedule inspections at the necessary construction phases with the proper Inspector(s). Attached inspection form must be completed & signed by the Lessee/ Applicant & Contractor.
- The Lessee/ applicant must submit proper Inspection forms to the Compliance Officer with the proper authority signatures. All Inspections must be conducted by a Licensed & Qualified Inspector.
- The Lessee/ Applicant must have 50% of the construction done by a tradesperson of the Beausoleil First Nation.
- It is the responsibility of the Lessee/ Applicant to ensure the contractors have a current WSIB Clearance Certificate. A copy of the certificate must accompany each application. Failure to provide proof of WSIB Clearance Certificate will result in your permit not being approved.
- Absolutely no construction shall commence until the Permit has been obtained & approved by the Lands & Resources Department. Should construction commence before approval of Building Permit, the Building Permit will automatically be revoked and all construction will be halted until the non-compliance is rectified. Failure to comply with building permit policy will result in the lessee being subject to a \$150.00 fee.
- All Building Permits are valid for only one (1) year.
- If an extension (of up to a maximum of 1 year) of a Building Permit is required, you must re-apply at the Beausoleil First Nation Lands Management Office. The cost of a Permit extension is \$ 200.00
- These procedures and Guidelines may be amended from time to time by the Beausoleil First Nation.
- ALL sites MUST be cleared of any dangerous or hazardous materials after any demolition.

SITE PLAN LAYOUT, SCHEMATIC AND/ OR DESIGN DRAWINGS

The objective of the submission of drawing or illustrated documents is to provide a visual of the nature of work to be completed and where the proposed work will be done on the Cottage Lot in relation to boundary lines, shorelines, and existing structures.

INFORMATION TO BE PROVIDED UPON SUBMISSION

A Site Plan Layout, drawings and supporting documentation shall include the following information:

1. The legal description and fire route address of lot for which the development is proposed.
2. A plan showing the location of proposed work and existing structures on the lot with distances (in. / ft.), high water mark on shorelines and lot boundary lines. If applicable, location of trees to be removed.
3. Complete set of drawings, plans, diagrams from the contractor engineer, company or manufacturer that include dimensions.
4. If the work will be constructed in phases, a schedule identifying the phases.
5. If an agent on behalf of the lease holder is submitting the Site Plan Layout and Drawings a statement of authorization from the leaseholder is required
