RE: ALL COTTAGE SUBDIVISIONS - DOMESTIC PETS & ANIMALS

Dear Lessee(s),

Be advised that concerns have been raised regarding pets or domestic animals not being secured on leashes. Although we all love our fur friends and pets, to ensure all residents, Lessees, and families feel safe and welcomed at the beaches. Any and all domestic animals must be secured on leashes, as per the Beausoleil First Nation By-law No. 20, subsection,

5.17 No person shall permit an animal on the beach where a sign or notice is posted by Beausoleil First Nation that domestic animals are to be kept on a leash.

Furthermore, the Beausoleil First Nation By-law No. 21, section 6, subsections 1-13, detail all the responsibilities of the Owner of any domestic animal currently on Beausoleil First Nation Territory. A few examples of these responsibilities listed in Section 6 of By-law No. 21 are:

- (2) No person shall suffer, permit or allow any animal of which he/she is the owner to run at large on the reserve.
- (3) For the purposes of this By-Law, an animal shall be deemed to be running at large if found in any other place other than the premises of the owner of the animal and not under the immediate, continuous and effective control of any person
- (4) For the purpose of this By-Law, an animal shall be deemed not to be under the control of any person when the animal is:
 - (a) not held on a leash by a person capable of restraining the animal's movements;
 - (b) not on a leash which is securely affixed to some permanent structure from which the animal cannot escape.

Please familiarize and abide by the rules listed in the By-laws, as the beaches are for the use and enjoyment of everyone, for any disturbances and disruptions please report to Compliance Officer Trainee, Connor Sunday, or the Anishinabek Police Services, contact information provided below,
